WIOA PROGRAMS - ADULT, DISLOCATED WORKER, AND YOUTH PROGRAMS FUNDED THROUGH THE WORKFORCE INNOVATION AND OPPORTUNITY ACT (WIOA) THROUGH THE U.S. DEPARTMENT OF LABOR PROVIDE FREE EMPLOYMENT AND TRAINING SERVICES TO ASSIST ELIGIBLE INDIVIDUALS IN FINDING AND QUALIFYING FOR MEANINGFUL EMPLOYMENT. SCSEP PROVIDES TEMPORARY COMMUNITY SERVICE TRAINING OPPORTUNITIES TO OLDER WORKERS OVER THE AGE OF 55 TO PREPARE THEM FOR JOBS IN THEIR COMMUNITY. SCSEP PARTICIPANTS TRAIN AN AVERAGE OF 20 HOURS A WEEK, AND ARE PAID A TRAINING STIPEND THAT IS THE HIGHEST OF FEDERAL, STATE, OR LOCAL MINIMUM WAGE DIRECTLY BY SCSEP. THIS ON-THE-JOB TRAINING EXPERIENCE CAN THEN BE USED AS A BRIDGE TO FIND EMPLOYMENT OPPORTUNITIES OUTSIDE OF THE PROGRAM. IN FY 2025, 143 OLDER

TALENT UP FAIRFAX - IN 2023, THE FAIRFAX COUNTY DEPARTMENT OF ECONOMIC INITIATIVES (DEI) AND THE SKILLSOURCE GROUP, INC. SUCCESSFULLY LAUNCHED TALENT UP FAIRFAX, A PILOT PROGRAM USING AMERICAN RESCUE PLAN ACT (ARPA) FUNDS, DESIGNED TO PLACE LOCAL FAIRFAX COUNTY JOBSEEKERS NEGATIVELY IMPACTED BY COVID-19 IN HARD-TO-FILL JOBS THROUGH PAID WORK-BASED LEARNING OPPORTUNITIES WITH FAIRFAX COUNTY EMPLOYERS.
